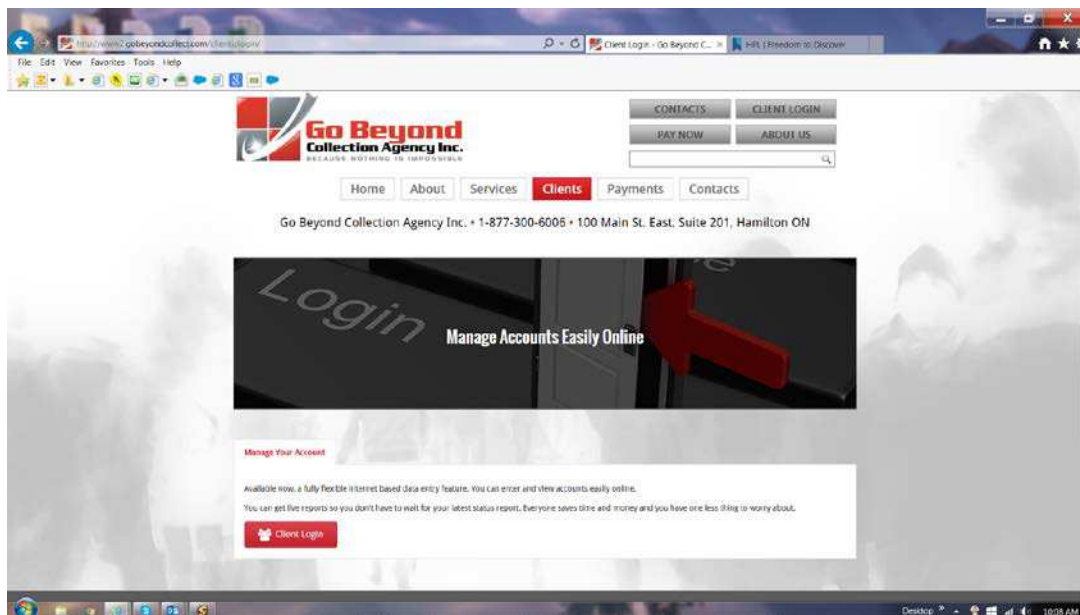

HOW TO LOG INTO THE WEBHOST SITE TO SEE LISTINGS!

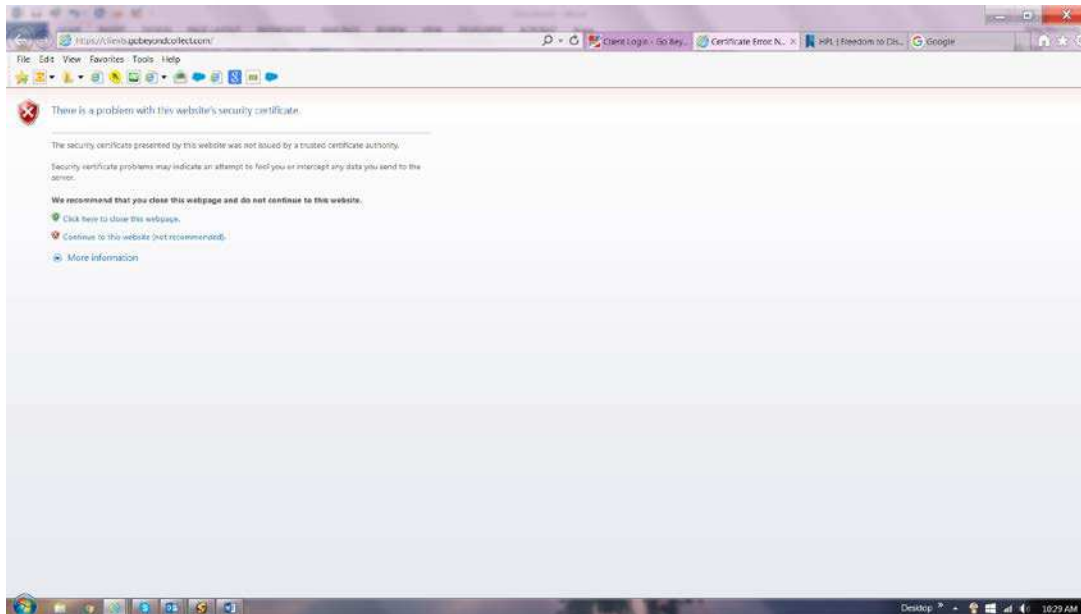
1. Open the **Go Beyond Collect** Web Site: www.gobeyondcollect.com

3. Click the red button Client Login.



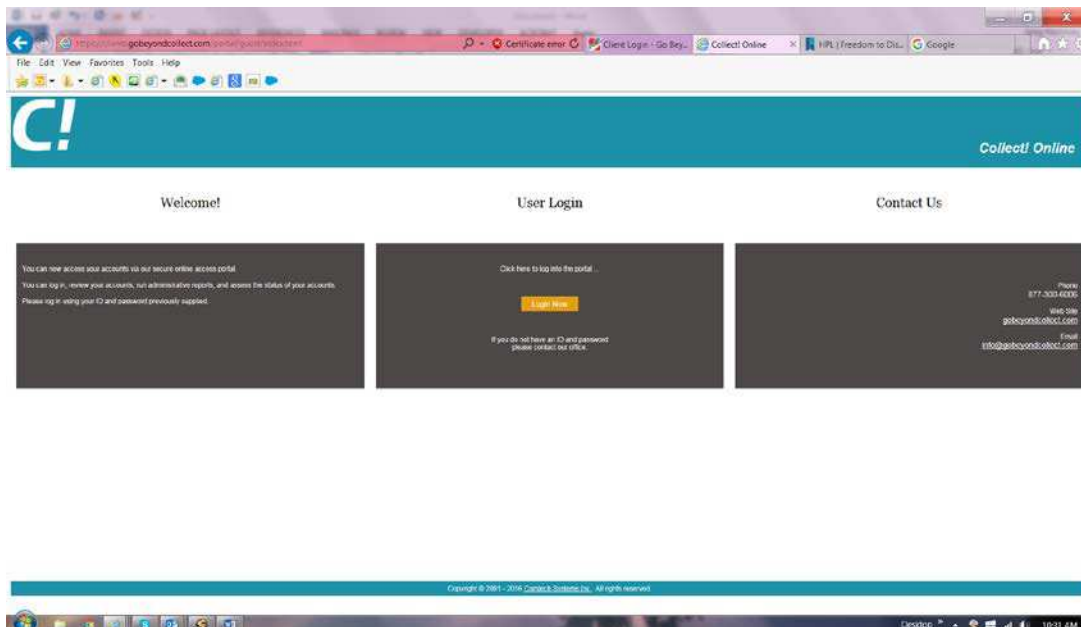
4. By clicking Client Login it will open a new browser tab.

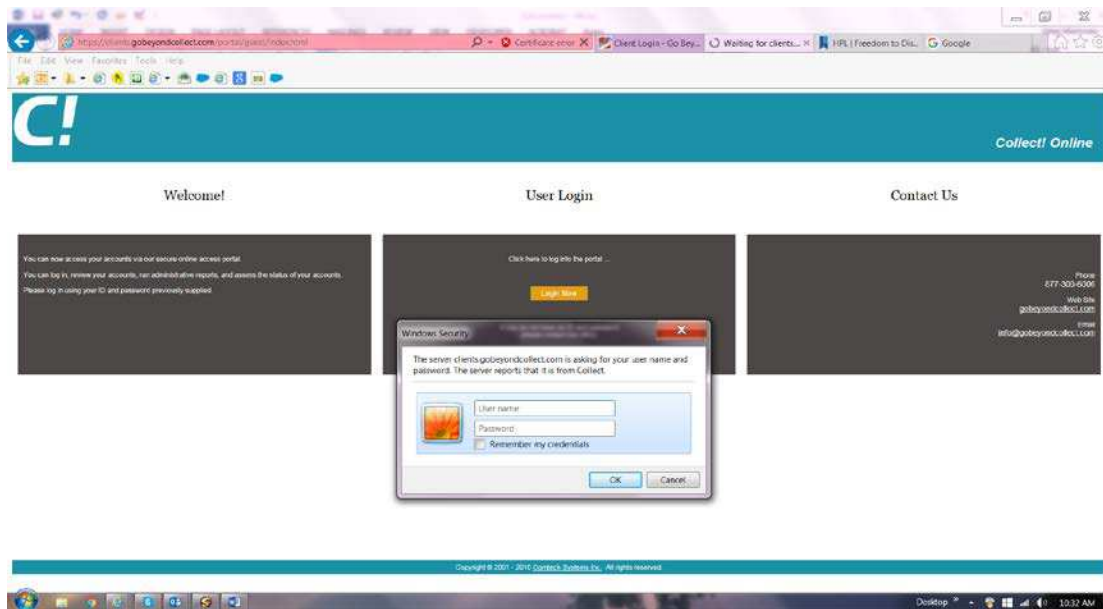


7. Click the Yellow Login Now button.
